IMPORTANT: All rider applications and <u>non-refundable</u> deposits are due by **June 1**st, **2018**. All checks should be made payable to the **BTRC** (Buffalo Therapeutic Riding Center). We will not hold your slot unless we have your deposit, <u>NO EXCEPTIONS</u>. The balance of your account is due by **September 1**st, **2018**. If we do not receive your balance by September 1st, you will be in jeopardy of losing your spot.

Upon receipt of your application we will send a confirmation letter indicating that your space has been secured and stating the balance of your account (including stabling, shavings and hay costs)

Dear Friends,

It is our pleasure to invite you to participate in the 2018 George Morris Clinic at the BTRC. The clinic will be held November 9th, 10th, and 11th, 2018. We are offering three levels to riders: Intermediate, Advanced, and Jumper. Each rider may invite *one* free auditor. **Please read the following information carefully. Plan on arriving Thursday, November 8th.**

Intermediate: Jump 3'-3'3" and will ride at 9:00 to 11:00 am every day. Advanced: Jump 3'3"-3'6" and will ride at 11:30 to 1:30 pm every day. Jumper: Jump 3'6"-4' and will ride at 2:30 to 4:30 pm every day.

Rider Fees: \$900 / rider (includes 3 riding days and free auditor)

\$950 / rider seeking credit for USHJA Trainer Certification

RIDERS

Each level has 8 available spots which will be filled on a *first come*, *first serve* basis. Riders must have reached their 14th birthday before participating in the clinic. We must receive a completed application along with your **non-refundable** deposit of \$400.00 to reserve a space. If your deposit is not received with you application, your spot is *not* guaranteed. Riders may each invite *one* auditor free of charge. Please clearly state your auditor's name in the space provided on the application.

STABLING

Be advised that stabling for your horse is not included in the clinic fee. Stalls will be available at the cost of \$140 for three nights (this includes arrival Thursday evening and *one* grooming stall). Additional stabling arrangements may be made at the cost of \$50/extra night. Shavings and hay are available for purchase at the cost of \$8.00/bag for shaving and \$8.00/bale. We will accept arrivals after 12:00 p.m. on Thursday, November 8th.

HEALTH INFORMATION

We will be requiring you to follow USEF protocol and health rules. Health papers, vaccination records, and a recent coggins should be sent in by **October 31**st.

TRAINER CERTIFICATION

This clinic has been distinguished as part of the **USHJA Trainer Certification Program**. In order to receive credit for this clinic, you must be registered with USHJA BEFORE you attend the clinic. You are also required to sign in and out each day and observe all three sections each of the three days.

REFUND POLICY

We understand that last-minute emergencies can occur. However, due to the popularity of our clinic, and the distance many of our participants travel to attend, we have instituted the following policy: In the event of a cancellation for any reason, refunds requested in writing before September 1st will receive all payments except the \$400 non-refundable deposit. This must include written information from a doctor or veterinarian. For any refunds requested after September 1st, your balance will be applied to an auditing slot.

MISC INFORMATION

Since we are located within the city limits, we must follow extremely strict leash laws. If you must bring your dog, please make sure they are on a leash at all times. They are not allowed in the lounge or in the box seating area. Please keep them within the barn areas at all times.

In the past we have been fortunate enough to enjoy a huge response from trainers seeking Certification Credit. For that reason, we kindly ask that only children who are old enough to be active participants attend the clinic.
